Subject: Delay in Acquisition of Property 2 Part B

- This is with reference to rated, listed, secured, non-convertible debentures aggregating to Rs. INR 3,25,00,00,000/- (Rupees Three Twenty-Five Crores only) ("NCDs") issued by WATERMARKE ESTATES PRIVATE LIMITED ("Issuer") under Debenture Trust Deed dated 18th November 2023 wherein we, Vistra ITCL (India) Limited ("Vistra"), are acting in the capacity of and as a Debenture Trustee for and on behalf of the debenture holders ("Debenture Holder") under the debenture trust deed ("DTD").

- In view of the above, we propose to convene a virtual meeting of the Debenture Holder(s) on 6th November 2024 at 12.00 pm of the Debenture Holder(s) under ISIN INE07J407014 for discussing the aforementioned-
 - (i) Declaring of breach of covenant;
 - (ii) Decision of declaring Event of Default; and
 - (iii) Steps to be taken in case of Event of Default and instructions from the Debenture holder(s) on the course of action to be taken for enforcement and/or remediation.
 - (iv) Positive consent for Inter-creditor agreement to be signed, if any.
 - (v) Appointment of Nominee Director on the board of the Issuer.
 - (vi) Negative consent for proceeding for enforcement of security
 - (vii) Positive consent for proceeding for enforcement of security
- The link of the meeting will be sent to the Debenture Holder(s) shortly under ISIN INE07J407014.
- In accordance with the Schedule I sub clause (1) of the Debenture Truste Deed, trustee may any time at the request in writing of the Debenture Holders representing not less than 1/10th (One Tenth) in value of the aggregate outstanding Debenture Amount, convene a meeting of the holders of all the Debentures. It is also notable that in case the default is cured between the date of notice and the date of meeting, then the meeting shall stand canceled, subject to the instruction of the Debenture Holder.
- A meeting may be called by giving not less than 21 days of the calendar notice in writing that is specified in sub-clause (2) of Schedule I of the DTD. Provided that a meeting may be called after
